

USA Padel Match Filming Policy

Purpose:

- To establish clear guidelines for filming USA Padel events, protecting players' privacy, promoting fair play, respecting the integrity of the sport, and enabling positive use of footage for player development.
- This policy applies to all play in all USA Padel tournaments, and Team USA events, and extends to players, spectators, club employees, and third-party videographers.

Policy Guidelines

1. Consent for Filming:

- **Prior Approval:** Before filming any match (full or partial), the individual or entity intending to film must obtain explicit consent from:
 - All participating players in the match.
 - The hosting club or tournament organizers.
- **Method:** Consent should be obtained using a standard USA Padel consent form (see Appendix A), which includes clear explanations about intended footage usage.

2. Restrictions on Footage Usage:

- **Primary Purposes:** Filmed material is primarily intended for:
 - Personal review by consenting players to analyze their performance and improve their game.
 - Instructional or training use with coaches, subject to players' consent.
- **Prohibited Uses:**
 - Self-officiating, or to challenge umpire decisions during or after a match. The USA Padel has established protocols for reviews and appeals.
 - Publicly criticizing or disparaging players, umpires, or USA Padel officials.
 - Any commercial purposes (e.g., selling, licensing, advertising) without additional written consent from the USA Padel and all relevant parties.

3. Sharing or Distribution of Footage:

- **Player Consent:** Players MUST obtain written consent from ALL other players featured in the footage before sharing or distributing it in any way (online, social media, with coaches, or any third party).
- **Sensitive Content:** Any distribution of footage that might be considered embarrassing, defamatory, or harmful to a player's reputation is strictly prohibited.
- **Respect:** Players sharing footage should exercise common courtesy and avoid any distribution that could cause personal or professional distress to another player.

Additional Considerations:

- **Tournament Organizers:**
 - May establish specific filming guidelines, designated filming areas, or require videographers to sign consent forms as part of their event regulations. Participants must abide by these regulations in addition to this USA Padel policy.
- **Official Videographers:** The USA Padel or tournament organizers may contract official videographers for promotional or training purposes. Separate guidelines for official footage usage will apply.
- **Filming of Minors:** Strict adherence to relevant laws, regulations, and child safeguarding protocols must be followed when filming matches involving minors. Parental or guardian consent is essential.
- **Live Streaming:** Any live streaming of USA Padel matches must be approved by USA Padel and abide by separate policies addressing broadcasting rights and player privacy.

Enforcement

- The USA Padel takes violations of this policy seriously. Disciplinary actions may include:
 - Warnings
 - Fines
 - Suspension from USA Padel events
 - Referral to legal authorities where necessary.

Policy Review

- The USA Padel will regularly review and update this policy to ensure clarity, align with evolving technology, and protect the best interests of the sport, its members, and officials.

Responsibilities

- **Players:** It is the responsibility of the players to be aware of this policy, obtain necessary consent before filming, and use and share match footage in accordance with the guidelines.
- **Hosting Clubs and Tournament Organizers:** It is the responsibility of clubs and organizers to abide by this policy and ensure its enforcement.
- **USA Padel:** The USA Padel is responsible for maintaining, updating, and enforcing this policy to protect the best interests of the sport and its members.
